

There are few areas of law that are subject to more myths than the law surrounding child support. This month we provide you with insight into a few of the more common myths we hear from clients and prospective clients about their child support issues.

Myth 1. Child support can only be reviewed every three years.

**Answer: False.** Child support can be reviewed AT ANY TIME by showing



Myth 2. If you and a co-worker make the same salary and you both have two children, your child support should be the same amount.

**Answer:** False. In Michigan, child support is set by a formula. There are several variables that are used in that formula including:

- 1. Mother's income:
- 2. Father's income: and
- 3. Parenting time arrangement (how many overnights the child or children spend with each parent).

Unless the co-parents also make the exact same amount and have an absolutely equal division of parenting time, the amount child support ordered by the court will be different.

**Answer:** False. Surcharges are no longer being added, and with a court-approved repayment plan, some accumulated surcharges (added between 2004 and 2009, for example) can be removed from your balance.

## The Morrill Act - Establishing Land Grant Universities

This year marks the 150th anniversary of the signing of the Morrill Act which created Land Grant Colleges throughout the United States for the study of agriculture and the mechanical arts as well as military tactics. The legislation, sponsored by Vermont Congressman Justin Smith Morrill and signed into law by President Abraham Lincoln, paved the way for each eligible state to sell 30,000 acres of Federal Land to raise funds to build colleges.



By the time that the Morrill Act was passed, Michigan had established the first land grant college. Michigan State University was founded in 1855 - using a State of Michigan land grant. As the original land grant college, MSU both benefited from the Morrill Act and quickly became the model future land grant colleges created through the legislation.

Seventy colleges and universities are land grant colleges and universities including two private schools: Cornell and the Massachusetts Institute of Technology, public schools like

### **Gary's At Home Cookin'**

#### **Kickin' Dilly Beans**

This summer Gary's in the kitchen and it's canning season. Here's his favorite version of classic "Dilly Beans" (pickled fresh green beans), kicked up by the inclusion of a few "Birds Eye" peppers, commonly used in Asian cooking.

Heat the canning solution:

5 cups water

5 cups vinegar

1/3 cup salt (canning or pickling salt is recommended)

Into each quart jar put:

1 dill head

Few cloves fresh garlic (sliced or chunked)

1/2 tsp. mustard seed

4-6 dried "Birds Eye" peppers (I buy them at The Spice Merchants, downtown Traverse City, and at Penzey's Spices)

Put the garlic chunks, mustard seed, and peppers into the jar, then pack in snapped (but raw) fresh green beans, put in the dill, and fill with hot fluid. Process in a hot water bath for 5 minutes. They are best if allowed to "rest" for at least 30 days before opening and enjoying.
